1. **Introduction**

- 1.1 IMOD, through its tender committee (the "**Tender Committee**"), is inviting Bidders who meet the Prerequisites for Participation (hereinafter defined), to submit their offers for the purchase of used **M113 APC**.
- 1.2 The available <u>APCs</u> include various types and models, which are offered for sale as-is, in their current condition and location, with no warranties or guarantees. IMOD will not be responsible for any actions related to the removal or relocation of the APCs.
- 1.3 Eligibility to Participate This tender is open to interested parties, both local and international, who meet the eligibility criteria as outlined in the tender documents.
- 1.4 Bidders who meet the following requirements are invited to submit a request to receive the tender documents:
 - 1.4.1 Israeli exporters approved by the Israeli Export Control Division (as defined in the Defense Export Control Law, 5766-2007).
 - 1.4.2 Bidders who are not Israeli exporters are invited to submit a request to receive tender documents through an Israeli exporter or after registering as SIBAT customers.
 - 1.5 For instructions on registering as a SIBAT customer, please contact the Tenders Committee Coordinator as detailed below.
- 1.6 It is hereby clarified that the tender documents will be provided to the bidder specified above only and IMOD and/or SIBAT is not obliged to respond to any request to receive the tender documents and is not obliged to justify his decision.



- 1.7 Notwithstanding anything in the Tender Documents to the contrary, the Deliverables, are to be purchased and collected by the Awardees with no guarantee regarding their technical condition and/or technical data and/or any other documentation and will be purchased by the Awardee(s) "AS IS". No warranty to the Deliverables or any obligations or commitments relating to their quality are being given by IMOD to the Bidders and/or Awardees, and the Bidders and/or Awardees shall have no claims whatsoever against IMOD regarding the Deliverables or their description. The Deliverables shall be delivered to the Awardee by IMOD only after and subject to obtaining Re Export Approvals, as detailed in this Tender, and according to the U.S. and Israel legislations.
- 1.8 The Bidder shall submit a bank guarantee or a guarantee issued by insurance company as detailed in Tender. Submission of any other form of security, including but not limited to cash deposit, bank check, personal check, or any guarantee other than a sound and valid guarantee as specified, shall not be accepted.
- 1.9 IMOD reserves the right to amend and/or change the terms and conditions of this Tender and/or any of the Tender Documents or to cancel this Tender entirely at any time at IMOD's sole discretion, all as further set forth hereunder.
